Motor Vehicle Court Order Fee: \$100 Value of the Vehicle Must Be Less Than \$5,000

Your Affidavit Must Contain the Following Information:

- 1. The current owner of the vehicle, name and address.
- 2. The date the vehicle was acquired.
- 3. Who was the vehicle acquired from and their last known address?
- 4. How much was this vehicle purchased for and was it paid in full?
- 5. Has the vehicle remained lien free?
- 6. Description of the vehicle including year and VIN number.
- 7. The circumstances why this documentation is not available.
- 8. The affidavit must be notarized.

You must acquire a physical inspection of the vehicle from the Louisiana State Police verifying ownership.

Bring the notarized affidavit, bill of sale and state police inspection to the Justice of the Peace's office to obtain a court order.

The Louisiana Office of Motor Vehicles will not accept a Court Order issued if no proof of ownership is provided (abandoned vehicles). You must obtain a Judgment from a District Court or contact a Sheriff regarding a "Sheriff's" or Judicial Sale.

Once the request is accepted by the office of the Justice of the Peace, no refunds can be issued. There is no guarantee that a Court Order will be issued in this case. It takes a minimum of 3 weeks for a response to be issued to the Justice of the Peace's office from the Louisiana Office of Motor Vehicles.
